NOTICE – TREE REMOVAL SIGNS

Per Sec. 14-54(c)(1)(f), all projects with tree removal must post a **Brookhaven Notice of Tree Removal sign**. Notice of Tree Removal signs may be picked between 7:30 A.M.- 4:30 P.M. Monday through Friday at City Hall, 4362 Peachtree Rd., Brookhaven, GA 30319.

POSTING REQUIREMENTS

- Post Notice of Tree Removal sign visible from the street but not in the right-of-way
- Post Notice of Tree Removal sign 5 days prior to removal of tree(s).
- Flag all trees to be removed with vinyl or duct tape 5 days prior to removal of tree(s).
- Removal of tree debris is the responsibility of the tree contractor and/or property owner.
- Remove sign and permit after tree removal is complete.

Failure to install and maintain a sign in good condition will be subject to mandatory stop-work orders (24-hour stop work for first offense, 48-hour for second offence and 72-hour for third and final offense). The third offense leads to a citation and a fine.

Failure to abide by tree removal sign and permitting requirements will also be subject to mandatory stop work orders, citations, and fines.

Habitual violators may lose the privilege of engaging in tree removal activity in the City of Brookhaven for a year.

City building inspectors, code enforcement officers, land development inspectors, and police officers are responsible for the enforcement of this ordinance.
